Water Rates:

0– 1,000	Gallons at \$32.00 (Monthly Minimum)
1,001– 5,000	Gallons at \$ 5.90 per thousand gallons
5,001– 10,000	Gallons at \$ 6.00 per thousand gallons
10,001– 20,000	Gallons at \$ 6.10 per thousand gallons
20,001– 50,000	Gallons at \$ 6.20 per thousand gallons
50,001– Over	Gallons at \$ 6.30 per thousand gallons

Water meters are read by the water supply's meter reader around the 24th of each month. The bills are mailed to the customers at the end of each month. You should receive your bill by the 7th of the month. Paperless bills are also available online at www.pendletonwsc.com. Failure to receive a bill does not justify an extension of the due date.

All payments should be received by the water supply by the 15th of each month. A \$12.00 penalty per meter will be added to each account with a balance on the 16th of each month.

If the bill and penalty are not paid by the disconnect date (25th), service will be disconnected, and a \$50.00 reconnect fee, along with all outstanding balances must be paid before service is restored.

If water service has been terminated and full charges for the water bill have not been received by the close of the regular business day, water service will remain off the rest of the day/night. Upon receiving payment in full, service will be restored during regular business hours. (A drop slot is located at the office and may be used at any time.)

Full payment is due by the 15th of each month. A \$12.00 late charge per tap is posted to all accounts with a balance on the 16th of each month. Failure to receive a bill does not justify an extension of the due date.

If the bill and penalty are not paid by the disconnect date (25th), service will be disconnected, and a \$50.00 reconnect fee, along with all outstanding balances must be paid before service is restored.

All returned checks, electronic-checks, debit, credit cards or any other reversed transactions by the bank or credit institution for any reason, will have a \$30.00 **Service Charge Fee** added to their account balance. Along with the original amount of the returned payment. Payments for the returned item and service charges must be paid by **money order or cashier's check. No checks from any other source can be accepted to remedy a returned check or electronic reversal of payment.** Pendleton WSC must receive the full payment for the check and service charge within ten (10) days from the date of the returned item. **Costly service termination can occur if this policy is ignored.**

Any person repeatedly providing corporation two (2) checks that are returned from the bank within a six (6) month period will be put on a **No Check or Credit Card** basis for a period of one year. If four (4) or more payments are returned in twenty-four (24) month time frame, the account will be put on a **No Check or Credit Card** basis indefinitely.
